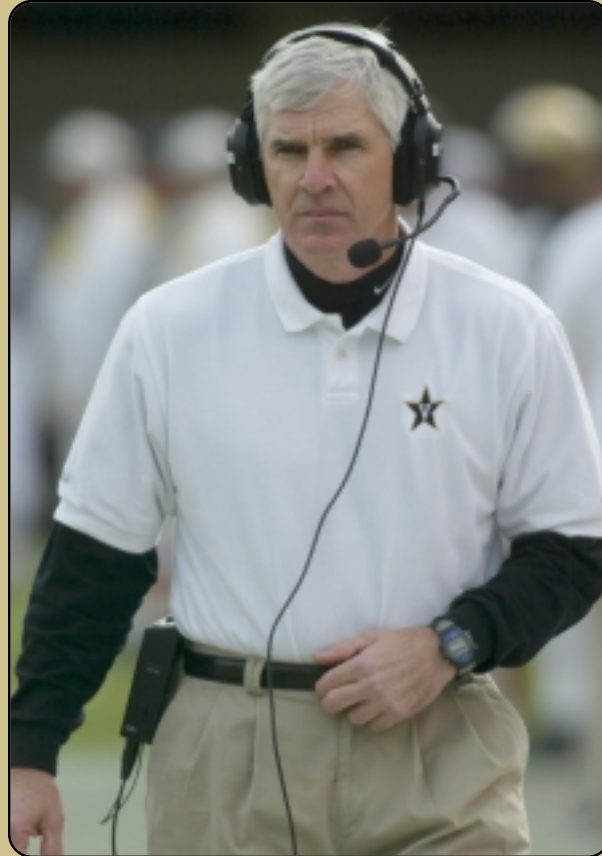

**Description:** The Commodore coaching staff will conduct a thorough speed, conditioning and agility evaluation and provide technique instruction at the Vanderbilt All-Positions High

School Camp. The camp offers professional-level instruction of football fundamentals and techniques.

**Check-In** From 8:00-8:45 a.m., check-in is scheduled *in the south end zone of Vanderbilt Stadium*. Access into the stadium is available through the field tunnel off Jess Neely Drive.

**Camp Schedule:** The camp will open at 9:00 a.m. with a speed, conditioning and agility evaluation by Vanderbilt coaches, following by individual instruction. After a lunch break, the afternoon session will feature individual skill drills and competitions.



## Middle School Camp

**Location:** John Rich Practice Complex

**Ages:** Students entering grades 6-8

**Cost:** \$40 Per Camper

**Description:** The Vanderbilt All-Positions Middle School Camp will offer thorough individual instruction from Commodore coaches. Each camper will receive one-on-one instruction focusing on fundamentals, sportsmanship and team play. The camp will stress drills and repetitions. Lunch is provided.



**Camp Schedule:** The camp will open at 9:00 a.m., with a morning practice starting the activities. After a break for lunch, an afternoon practice is scheduled. Coach Johnson will address the campers to conclude camp activities.

**Check-In:** From 8:00-8:45 a.m., check-in is scheduled *in the south end zone of Vanderbilt Stadium*, home of the Commodores. Access into the stadium is available through the field tunnel located off Jess Neely Drive.
