- IT Customer Satisfaction Survey
 - This is our first ever fac/staff customer satisfaction survey, but it will be annual.

Guest speaker: Susan Wente, Provost

One Vanderbilt idea. I am the first provost who played a role in the School of Medicine.

Will be focusing on 8 schools and colleges out of 10 (excludes Nursing and Medicine).

Example of scope: In Fall 2014, 37% of our students are enrolled in A&S and 20% of our students are enrolled in the graduate school.

Faculty numbers closely parallel those of the students, but 47% of faculty are in VUMC versus only 12% of students, and there is no faculty in the graduate school (they are appointed by schools).

First six months:

I have been meeting with the team, discussing vision and shared governance.

Listening tour includes fac, students, staff, alumni, board trustees.

Embody the goals of the Strategic Plan.

It's been 12 years since we've done strategic planning so there wasn't really a team in place to implement it.

The Provost Office needs capacity and bandwidth to handle VUMC split, too.

Reorganization included appointing John Geer Vice Provost for Academic & Strategic Affairs

Searches underway for the Dean of College of A&S, Dean of Graduate School, Vice Provost for Research, Library leadership, and Dean of the Ingram Commons.

Our strategy and priorities: We can jump in right now and make change.

1. To provide intellectually rich and diverse campus learning community that educates the whole person and cultivates lifelong learning

- 2. To expand research and teaching collaborations across disciplines to solve critical problems and embrace discovery and learning.
- 3. To harness our strengths in all disciplines to address pressing health and healthcare issues.
- 4. To transfer education models through technology and research

Phases of Strategic Planning: We are developing a robust communications plan as we go through the phases.

Vision (first year, engaging university, identifying strengths and challenges, articulate aspirations)

Actions (activate faculty, staff, and students; set priorities; launch initiatives; ID resources) Impact (measure progress, adjust and refine action, re-engage vision)

Faculty committees have been formed to work on initiatives.

Staff Advisory group formed also with an open-ended charge.

- Will serve as sounding board
- Flag potential challenges
- Drafting implementation recommendations (cross-college teaching)

Trans-institutional programs

- *Goals:* Advance One Vanderbilt, address problems and questions that are ambitious, innovative and inspiring
- *Call for proposals:* Vanderbilt Initiative Awards(ViA)- incubator phases; Vanderbilt Reinvestment Awards- commitments to successful ViA programs, or existing TIPs.
 - o 100+ pre-proposals submitted for December 2014 deadline

Chancellor's faculty fellows

- When we recruit someone, we give them resources to succeed and want to keep them here, but then once they get tenure their research accounts have often been exhausted.
- Commitment to invest in outstanding junior faculty and keep them here
- Designed to ensure scholarly success
- Fellows will meet regularly to build broader intellectual community, foster transinstitutional collaborations
- \$40,000 over two years
- *Nominations:* over 60 were nominated

Looking ahead

- Vanderbilt Visions to introduce the Immersion Experience
- TIPs may leverage College Halls, drawing more faculty to residences
- Student interactions in the Immersion Center will draw students to innovation environments
- Engineering and Science building opens Summer 2016

Restructuring: VUMC and VU Split

- Organization of VUMC-associated functions in a new structure
 - o Faculty and students will still be working together
 - o Position VUMC to be nimble in the healthcare environment, also help VU be more nimble and quickly address problems/challenges in higher education
 - We have opportunity to get this right (affiliation agreement)
 - o Education and basic sciences stay at VU
- Provost Team Management
 - o Tim McNamara, John Geer, Cynthia Cyrus
- Vanderbilt's values and visions
 - o Offer outstanding educational experience and undertake world-class research; want to guarantee two goals are mutually reinforcing
- The Vanderbilt Way
 - Discovery and Learning
 - o Drive by our values, vision, strengths and strategy

Questions:

When will the Dean of the Commons be here?

By the fall semester. The applications are already in and being reviewed.

When we become separate entities: will benefits change?

No, you shouldn't notice any changes when the switch is flipped. There will need to be administrative changes for legal and fiduciary reasons.

Regarding us losing faculty, is the reason lack of research dollars?

Several reasons. Tenured professors are attractive to our peers. Assistant professors are more risky.

Are there programs in the works to retain quality staff?

You have to have competitive pay and job architectures. I look to HR for that. Career development programs are also important to make people feel more a part of the organization. We always have work to do in these areas. Any ideas this group has would be listened to very seriously.

How would you rate overall organizational communication effectiveness 1-10?

Overall, this is hard because there are probably some areas where we are doing a great job and others where we are doing a horrible job. So I might say a 5. I know I've been trying to develop more mechanisms to communicate. A new e-newsletter will be coming out from the Provost with a tentative title of *The Open 'Dore* (...to the Provost Office). This will have new information and also summarize information that comes out from multiple sources like myVU. We are a large organization and that makes communication challenging. We have to rely upon you also to communicate out.

Staff aren't mentioned in the five-year rule. How are you working on pairing up staff with faculty on committees?

Staff aren't excluded, and are included where appropriate. We can bring in recommendations from the Staff Advisory Group.

Michelle: We have two reps that are on it, Melissa and Rachel. They have met three times.

What changes are you most excited about and what changes make you nervous?

I am excited about everything we're doing to move Vanderbilt forward. That which is not done being planned does make anyone nervous. We need to get the restructuring right, so it is something I think about.
