K-Camp dates are July 6 – 30, 2021. K-Camp hours are 8:30 AM – 3:30 PM.

I understand that it is my responsibility to ensure that my child will be signed in at The Acorn School location to which they are regularly assigned in accordance with child care licensing regulation.

K-Campers that arrive before 8:30am and stay after 3:30pm will receive child care on site in their current Acorn classroom from 7:00 AM – 8:30 AM and 3:30 PM – 6:00 PM. Children that arrive later than 8:30 AM may not be taken to K-Camp but will be incorporated into a preschool classroom for the day.

I understand it is my responsibility to ensure my child is signed out at the child care center in accordance with child care licensing regulation. Parents that arrive unexpectedly to pick-up early (before 3:30 PM) will have to either meet the K-Campers at their field trip location or wait until their K-Camper arrives back to the child care center.
