# **Child Abuse Reporting**

- Vanderbilt University personnel adhere to Tennessee state law on mandatory child abuse reporting to either the appropriate law enforcement agency or the state hotline operated by the Department of Children's Service.
- In addition to external reporting, Vanderbilt has a <u>mandatory</u> internal child abuse reporting procedure.
- If you have reason to believe abuse or inappropriate behavior has occurred concerning a minor on campus or participating in a Vanderbilt University program, please consult the program director, event host, or Risk Management (615-936-0660), or report via the Vanderbilt hotline at 866-783-2287. The Tennessee Child Abuse reporting hotline number is 877-237-0004.

#### **VU Code of Conduct for Interacting with Minors**

- You are required by Tennessee law and Vanderbilt University policy to report actual or suspected abuse or other improper conduct involving a Minor. You also are also required to comply with the following code of conduct when interacting with Minors.
- Do not spend time alone, either on or off campus, with a Minor away from others. If one-on-one interaction is required, meet in open, well lit rooms or spaces with windows observable by other adults from the Program.
- Do not engage in any sexual actions, make sexual comments, tell sexual jokes, or share or view sexually
  explicit material with or within the vicinity of Minors.
- Do not touch Minors in a manner that a reasonable person could interpret as inappropriate.
- Do not shower, bathe, or undress with or in the presence of a Minor.
- Do not engage in any abusive conduct of any kind toward, or in the presence of, a Minor, including but not limited to verbal abuse, hitting, punching, poking, or restraining, except as required to protect a Minor or others from harm. All incidents involving such conduct, whether or not required to protect a Minor or others from harm, must be documented and disclosed promptly to the Program Director and the Minor's parent/guardian.
- Be aware of the impact of your words and language on Minors.
- Do not use, possess, or be under the influence of alcohol or illegal drugs while on duty or when responsible for a Minor's welfare.
- Do not meet with Minors outside of established times for Program activities. Any exceptions require parental
  authorization and must include more than one adult from the Program.
- Do not engage or converse with Minors through email, text messages, social networking websites, or other forms of social media at any time except and unless there is an educational or programmatic purpose and the content of the communications is consistent with the mission of the Program and the university.
- When transporting Minors in a Program, more than one adult from the Program must be present in the vehicle, except when multiple Minors will be in the vehicle at all times through the transportation. Avoid using personal vehicles if possible.
- Do not tell children "this is just between the two of us" or use similar language that encourages Minors to keep secrets from their parent/guardians.

## **Protection of Minors**

#### <u>"Take-aways" to remember when working with minors – Protect,</u> Observe, Manage, Report:

- •Rule of three (at minimum); two deep leadership
- If you see something, say something Risk Management 615.936.0600 or VU Hotline 1-866-783-2287
- •TN is a mandatory child abuse reporting state: 877-237-0004
- •Know and understand how to keep healthy boundaries, minimize opportunity for abuse
- •Group communication always no one-to-one

Vanderbilt Minimum Allowable Ratios for Programs with Minor Participants (ACA Recommendations)

Age	Day Event/Camp Ratio	Overnight Ratio
5 years and younger	1 Adult : 6 Minors	1:5
6-8 years	1:8	1:6
9-14 years	1:10	1:8
15-18 years	1:12	1:10

# **Policy Attestation Required**

- After you complete the UE training, there is <u>one more step</u> to meet training compliance.
- Read the **Protection of Minors Policy HERE**.

- Vanderbilt and third party programs that interact with minors must have personnel complete training and policy attestation annually. Criminal Background clearance that is acceptable to the University must also be completed.

Vanderbilt's intention in the Protection of Minors policy is to create an institutional awareness which improves the safety for minors in Vanderbilt programs and operations; any reporting will be viewed as a good faith effort to adhere to the reporting requirements.

### **Compliances Overview**

- To be in compliance with the Protection of Minors Policy, personnel, including faculty, staff, students and volunteers must:
  - Have a background clearance on file (minimal requirement is every four years – programs may require more frequently)
  - Annual Protection of Minors Training
  - Annual Policy Agreement
